## Section 4 - First Aid Measures

---

### General Information:

## Section 6 - Accidental Release Measures

---

**Accidental release:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include neoprene. If there is a significant chance that dusts are likely to build up in cleanup area, we recommend that you use a suitable dust mask.
